





- Potential FY24 Funding
- BIL funding SAW has conducted an assessment of the condition of significant upland placement areas.
- Planning Assistance to States Non-Federal Dredged Material Placement Site Assessments
- Long-term MOA with North Carolina Department of Environmental Quality
 - > Original MOA: 5-year term was executed 14 November 2013.
 - Increased yearly contributions from to \$4.0M to \$12.0M per year.
 - > Extended the work period of the MOA through FY26.
 - > All Low Use Projects to include the AIWW and shallow-draft coastal inlets

- Impacting our ability to maintain waterways
- Private / Public use of Federal Placement Areas Excess Capacity

- Limited Placement sites (southern NC) nearing/at capacity
 - Topsail Beach area
 - Wrightsville Beach area
 - Masonboro Island
 - Southport
